The Canadian nutraceutical, natural health product and functional food industry has garnered a great deal of attention and enthusiasm on the part of governments, the agri-food sector, health care and research communities in Canada for its significant potential to provide:

- Diversification and market growth for Canadian agriculture and marine based industries
- Increased economic development in Canada
- Reduced health care costs for all Canadians
- Improved health and well-being and disease reduction for all Canadians

The Canadian industry is characterized by small and medium sized companies that are science-based and focused heavily on research and development to leverage health applications of value-added ingredients from basic agricultural and marine commodities. The industry is moving increasingly to branding of its ingredients, with larger companies bringing the products to market. Functional food ingredient manufacturers face much different challenges than traditional food producers or supplement manufacturers in many aspects of product development, research and marketing.
